

## **City of Virginia Beach Republican Party**

### **Official Call for a Party Canvass**

**Issued February 12, 2024**

As Chairman of the Virginia Beach Republican Committee and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Bill Curtis, do hereby issue this call for a Party Canvass to be held at the Meyera E. Oberndorf Central Library, 4100 Virginia Beach Blvd, Virginia Beach VA from Noon to 3 PM local time on Saturday March 23, 2024, for the following purposes:

- A. Electing a Chairman for the Republican Committee of Virginia Beach.
- B. Electing up to 3,840 Delegates and alternates to the 2<sup>nd</sup> Congressional District Republican Convention being held on April 27, 2024, at the Wave Church, 1000 N. Great Neck Road, Virginia Beach VA. Doors open at 10 AM local time. (NO FEE)
- C. Electing up to 3,840 Delegates and Alternates to the Virginia State Republican Convention being held on May 31, 2024, to June 1, 2024, at the Hampton Roads Convention Center, 1610 Coliseum Drive, Hampton Virginia. (There is a \$45.00 fee in order to participate in any convention elections other than for president).
- D. Reconstituting the Republican City Committee of Virginia Beach.

#### **Qualifications for Participation**

All legal and qualified voters of Virginia Beach, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of the Republican nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meeting, party canvasses, convention or primaries encompassing their respective election districts.

#### **Filing Requirements**

Candidates for the election to the office of unit Chairman, shall file a Declaration of Candidacy in person or by mail to Vice Chairman Nanette Miller, RPVB Office, 2955 Virginia Beach Blvd., Ste 105, Virginia Beach no later than 5 PM local time on February 20, 2024. These forms can be mailed but postmarks do not govern. Should only one candidate properly file by the deadline that that candidate shall be declared the winner and the canvass will be cancelled.

Applications to be delegates to either the 2<sup>nd</sup> District Convention, the Virginia State Convention or both need to be filed to Vice Chairman Nanette Miller, RPVB Office, 2955 Virginia Beach Blvd., Ste 105, Virginia Beach, VA no later than 5 PM local time on March 22, 2024. Only original documents are

acceptable. The forms can be mailed but postmarks shall not govern. All people properly filing for delegate shall be elected unless the number of delegates exceeds the maximum number permitted.

Person electing to join or rejoin the Republican Party of Virginia Beach at this time must submit a completed filing form.

## **FEES**

There will be a \$500.00 nonrefundable registration fee to participate as a candidate for Unit Chairman. The payment must be by check or money order and made payable to the Republican Party of Virginia Beach. This payment must be turned in with the Unit Chairman Declaration of Candidacy Form.

There is no fee to file as a delegate to the 2<sup>nd</sup> District Convention.

There is a \$45.00 filing fee to file as a delegate to the Virginia State Convention. There is no fee if the person elects only to vote for president at the convention. The payment must be by check or money order and made payable to the Republican Party of Virginia Beach and accompany the Filing Form.

Should a person elect to join or rejoin as a Unit Committee Member the dues are \$50.00. The payment must be by check or money order and made payable to the Republican Party of Virginia Beach and accompany the Filing Form. Due by 5PM local time on March 22, 2024. Postmarks do not govern.
